If an applicant's religious observance prohibits he/she from taking the test on a Saturday, the applicant may request an alternate test date. The applicant must submit a completed application form, an additional \$50 administrative fee, and a verification letter confirming the applicant's affiliation with a recognized religious body that observes its Sabbath on Saturday. The letter must be submitted on letterhead from the religious organization and signed by a minister, priest, or rabbi.

## **NNCC HOSTING CRITERIA**

- ◆ An ANNA chapter, ESRD Facility or Corporate Dialysis Provider must host the examination. Decisions regarding the test site will be made pending approval by the commission
- ◆ An individual must serve as the coordinator and contact person. A second person should be available as back-up in case the coordinator is not available.
- ◆ An examiner and proctor will be assigned by the testing agency (CNET). The examiner has complete responsibility for the administration and security of the test and should not delegate that responsibility to any other person. Note that no person is permitted to look at the test question except the applicants for certification who are admitted to the test site. A \$250 fee payable to NNCC is required for the hosting fee and must accompany the application. This fee is non-refundable.
- ◆ The host is responsible for securing a location in which the examination can be administered and must provide an exact address when submitting the application. The room should be set classroom style, which allows for placement of examinees at every other seat.
- ◆ The host will select the hour of the examination allowing 30 minutes for exam instruction and four hours for the examination (three hours for the CCHT examination only). Candidates are instructed to arrive 30 minutes before the examination for check-in. If possible, plan for the afternoon testing to allow those from out-of-town to travel in the morning.

**NOTE: PLEASE REFRAIN FROM SCHEDULING AN EXAM WITHIN 2 WEEKS OF THE LOCATION EXAMINATION DATES IN THE SPRING AND FALL**
